

RENTAL AGREEMENT

This Rental Agreement ("Agreement") is entered into between Faithful Party Rental and Supplier ("Lessor") and the undersigned Renter ("Lessee"). By signing this Agreement, the Lessee agrees to rent equipment from the Lessor under the following terms and conditions:

1. Responsibility, Use, and Disclaimer of Warranties:

Lessee assumes full responsibility for the operation and use of rented items. The Lessee agrees to indemnify and hold Faithful Party Supplier and Rental harmless from any claims, damages, or injuries (including death) resulting from the use or possession of the rented equipment. The Lessee acknowledges that no warranties, express or implied, including merchantability or fitness for a particular purpose, have been made by the Lessor in connection with the rented equipment.

2. Equipment Failure:

Lessee agrees to immediately discontinue use if equipment becomes unsafe or defective and must notify Faithful Party Rental and Supplier within one hour of discovery. The Lessor will attempt to repair or replace the equipment at its discretion. Lessor shall not be liable for any damages or injuries resulting from equipment failure.

3. Use of Equipment:

Lessee agrees that the rented equipment will only be used at the specified address in the contract and solely for its intended purpose. Subleasing or improper use is strictly prohibited. Lessee must review and follow all safety and operational instructions before use.

4. Equipment Responsibility:

Lessee is responsible for equipment from the time of possession until return. Any loss, theft, or damage (excluding normal wear and tear) will be the sole responsibility of the Lessee, who must cover the full cost of repair or replacement.

5. Time of Return:

The rental period ends as specified in the contract. Any extension must be approved in writing. Late returns will result in additional rental fees.

6. Payment and Deposits:

Lessee agrees to pay all rental fees in advance. A non-refundable deposit of 25% of the rental total is required at the time of reservation. If the reservation is canceled, the deposit is forfeited. Cancellations within five (5) days of the rental date will result in a 50% charge of the total rental cost.

7. Additional Charges:

Lessee agrees to pay additional fees for services such as delivery to non-level ground, after-hours delivery or pickup, setup and breakdown, cleaning of dirty equipment, or failure to return packaging materials.

8. Delivery and Pickup:

Lessee must have the site prepared for delivery and pickup. If equipment is not ready for pickup, additional charges may apply. Lessee is responsible for making equipment accessible at the agreed-upon pickup time.

9. Care of Equipment:

Lessee must take reasonable care of rented items, protecting them from weather damage, theft, and misuse. Any required cleaning or repairs will be billed to the Lessee.

10. Insurance:

Lessee is responsible for maintaining sufficient liability, property, and casualty insurance coverage for the rented equipment. In case of loss or damage, the Lessee agrees to assign any insurance proceeds to Faithful Party Rental and Supplier.

11. Permits and Licenses:

Lessee is responsible for obtaining all necessary permits and licenses required for installation and use of rented equipment, including but not limited to tents and inflatables.

12. Subsurface Conditions:

Lessee is responsible for ensuring that underground utilities are properly marked before delivery. Faithful Party Supplier and Rental is not liable for damage to underground utilities, including sprinkler systems.

13. Hold Harmless Agreement:

Lessee agrees to indemnify and hold Faithful Party Rental and Supplier harmless from any claims, losses, or damages arising from the use of rented equipment.

14. Damage Waiver:

If the Lessee opts for the damage waiver, the Lessor will cover accidental damage except for theft, misuse, abuse, or intentional damage.

15. Returned Checks:

A \$35.00 fee will be charged for any returned checks.
